## **REQUEST FOR EXPRESSION OF INTEREST**

This request for Expression of Interest follows the approval of Lagos State Government for Lagos Water Corporation to dispose its unserviceable vehicles and electro-mechanical equipment and therefore intends to request interested public to express their interest with proposal to purchase the unserviceable vehicles and scrapped materials in the corporation.

The materials available for bid are packaged into different lots as follows:

- 1. Unserviceable vehicles such as pickup vans, cars, Lorries, bikes etc in various locations of Lagos Water Corporation service areas (Lots 1A N) (Lot 3).

The piece of paper (letter) must be in sealed envelope with the Name of bidder, Description of the item and the LOT Number boldly written at the back of the envelope. **Bidders can bid for more than ONE Lot** but must be in separate envelopes.

The price of your quotation shall clearly indicate the total price you are offering for the materials in the lot being applied for. Where discount is being offered, bidder must indicate in the letter. The payment by winners shall be made within 48 hours and materials evacuated within two weeks from the date of signing of acceptance of offer. Where a winner fails to effect payment and evacuate the item(s) when due, the second ranked person in the LOT shall be invited to pay and take possession.

#### **CLOSING AND OPENING OF BIDS**

Bids must be delivered to the address below on or before **12 noon, Tuesday 8<sup>th</sup> June, 2021. Bid opening commence immediately**. Late submission will be rejected.

The process shall be conducted by open bidding.

Bids will be publicly opened Lot by Lot in the presence of the public, bidder's representatives and anyone who choose to attend. Bidders are advised to inspect the item (s) they are interested in before bidding for any LOT. The highest bidder (highest quotation) shall be declared as the winner for each LOT and shall be announced immediately in the presence of bidders or their representatives.
