1.0 INTRODUCTION

3.0 Bidding will be conducted through Selective Tendering Method procedure as specified in the Lagos State Public Procurement Guidelines.

4.0 QUALIFICATION REQUIREMENTS / ELIGIBILITY CRITERIA:

- (1) Evidence of Registration with the Corporate Affairs Commission (CAC) with the inclusion of Certificate of Incorporation and Articles of Association.
- (2) Current Company Tax Clearance Certificate corresponding with the Company annual turnover for three years 2018, 2019 & 2020 (expiring by 31/12/2020).
- (3) Possession of experience as Prime Contractor in at least (2) projects of similar nature and complexity with verifiable letters of contract award and certificate of job completion within the last five years.
- (4) Detailed Company profile and Organization structure including names and telephone numbers of key personnel (Technical / Managerial).
- (5) Evidence of financial capability (Reference letter from a reputable bank).
- (6) Copies of VAT Registration with TIN number and evidence of VAT remittances for the last three years.
- (7) Company's Audited Accounts for the last three years (2018, 2019 & 2020).
- (8) Evidence of registration as a Contractor with appropriate class, with Lagos State Government.

- (9) Sworn Affidavit confirming that all documents submitted are authentic.
- (10) All copies of all the documents provided in the bid shall be signed by the person duly authorized to sign on behalf of the bidder.

5.0 COLLECTION AND SUBMISSION OF BID

5.1 A complete set of Bidding Document in (English Language) may be purchase by your company at the Authority upon the payment of non-refundable fee of N20,000.00 (Twenty Thousand Naira) only, payment should be made to Government account, details of the account should be taking at the Account Department, LAWMA Ijora.
