3.0 QUALIFICATION REQUIREMENT/ELIGIBILITY CRITERIA

- **Interested and Competent Contractors/Consultants wishing to carry out the exercise described above will be required to submit the under listed documents.**
- **Each document is to be scanned and uploaded separately to the Lagos State Public Procurement Agency's E-Tendering Portal:**
 - (i)** Evidence of Registration with the Corporate Affairs Commission (CAC) with the inclusion of Certificate of Incorporation and Articles of Association.
 - (ii)** Last 3 years **(2019, 2020 & 2021)** Company Tax Clearance Certificate.
 - (iii)** Possession of experience as a Prime Contractor/Consultant in at least (2) projects of similar nature and complexity with verifiable **LETTERS OF CONTRACT AWARD AND CERTIFICATES OF JOB COMPLETION** within the last Five (5) years.
 - (iv)** Detailed Company profile and Organisation structure including names and telephone numbers of key personnel (Technical/Managerial).
 - (v)** Evidence of financial capability (Reference letter from reputable bank), demonstrating access to lines of credit to meet a cash flow requirement.
 - (vi)** Copies of VAT Registration with TIN number and evidences of VAT remittances for the last 3years.
 - (vii)** Company's Audited Accounts for the last three years. **(2019, 2020 & 2021).**
 - (viii)** Evidence of 3 years development levy for two directors.
 - (ix)** Evidence of registration as a Contractor with the Lagos State Government as Works Contractor with appropriate class.
 - (ix)** Sworn Affidavit confirming that all documents submitted are authentic.
 - (x.)** All copies of all the documents provided in the bid shall be signed by the person duly authorized to sign on behalf of the bidder.

- (ii)** All claims must be adequately substantiated with documents and must be verifiable.
