The Lagos State Government through the Federal Republic of Nigeria has received financing from Agence Française de Développement ("AFD") for the Lagos Strategic Transport Master Plan Project (LSTMPP 1) and intends to use part of the funds thereof for payments under the following service: **Consultancy Service for the Update of the Strategic Transport & Mobility Master Plan for Lagos Mega City Area.**

Objective and Outputs of the Consultancy

The Consultancy's Main Objective is to update, upgrade and extend Lagos State's vision for the transport and mobility system of the Mega City Area to 2040.

Expected Outputs of the Consultancy Services are:

- (i) Updated, upgraded and extended Strategic Transport & Mobility Master Plan to 2040 including the Public Transport Integration Master Plan, the Freight Master Plan, the Non-Motorized Mobility Master Plan, an Inland Waterways Transport Master plan, cost estimate, phasing-out and action plan, including a climate risk assessment;
- (ii) Updated Transport & Mobility Model based on LAMATA's current Transport Demand Model and its Geographic Information System (GIS);
- (iii) Mobility and Socio-economic surveys showing new and future mobility patterns in Lagos Mega City area;
- (iv) Capacity-building of LAMATA through technical assistance to ensure subsequent strategic studies under the LSTMPP-phase 1 project are consistent with the new Strategic Transport and Mobility Master Plan (STMMP).

Only for information purposes, there are a set of other consultancy services to be procured under the AFD-assisted LSTMPP-phase 1 project that will interact with the present consultancy services: (i) Freight Regulatory Framework, (ii) Regulatory Safety Standards and Public Operation Manuals for Public transports, (iii) Urban Traffic Management Control policy.

Scope of Services

- (i) Undertake review of the Lagos State's transport policy, legal, and institutional framework;
- (ii) Analyze the transport regulation model, the operation and business plans of the public transport system, the procedures for issuing licenses and managing contracts with operators;
- (iii) Analyse Lagos Mega City Area transportation system road and inland waterways networks, private and public transport means, institutional and paratransit industries;
- (iv) Collect comprehensive transport and travel data collection carrying out socio-economic surveys including Origin-Destination (O-D) surveys to provide detailed picture of trip patterns and travel choices;

- (v) Identify current and future urban centers (residential, commercial and industrial) and mobility patterns based on socio-economic surveys, climate change risk assessment and land-use mapping;
- (vi) Update Transport & Mobility Model based on LAMATA's current Traffic demand model as well as its GIS to develop a comprehensive vision of current and future mobility patterns;
- (vii) Develop an intermodal road and inland waterways network with different levels of corridors to channelize flows of people and goods;
- (viii) Elaborate institutional, physical and fare integration policy;
- (ix) Develop a Public Transport Integration Master Plan, a Freight Master Plan, a Non-Motorized Mobility Master Plan, with cost estimate, phasing-out and action plan;
- (x) Establish the Strategic Transport and Mobility Master Plan (STMMP) carbon footprint of current situation and targeted situation by 2040;
- (xi) Elaborate a STMMP Results framework with key performance indicators to monitor progress.
- (xii) Provide technical assistance to LAMATA to ensure wide STMMP ownership, capacity-building for transport planning, and consistency of other strategic studies with STMMP.

The Lagos Metropolitan Area Transport authority (LAMATA) hereby invites eligible consultants to show their interest in delivering the service described above.

This Request for Expressions of Interest is open to: **Consulting Firms.**

The services are anticipated to start by: **January 2023, over a period of 24 months.**

Eligibility criteria to AFD financing are specified in sub-clause 1.3 of the "Procurement Guidelines for AFD-Financed Contracts in Foreign Countries", available online on AFD's website: <http://www.afd.fr>.

Interested consultants must provide information evidencing that they are qualified and experienced to perform this Service. For that purpose, it is required to provide:

- 1) Experience:** general presentation of the consultant (all members in case of JV), and documented evidence of similar services finished in the last 10 years shall be submitted.

Determination of the similarity of the experiences will be based on:

- The contracts size;
 - The nature of the Services: Urban transportation Planning and modelling.
 - The technical area and expertise: Urban Transport Planning, Public transport planning, transport modelling, urban freight & logistics, data collection, travel demand/mobility management, highway engineering, strategic environmental impact assessment, project and investment programming, project appraisals and financial modelling and training.
 - The location: Lagos, Nigeria or cities with similar socio-economic characteristics
- 2) Expertise :** present the availability of technically skilled and sufficient personnel to effectively execute the assignment, through providing a list of CVs in the necessary fields. Local expertise is also to be presented.
 - 3) Tools :** present the availability and experience of the adequate tools to carry out the project, including adequate traffic modelling and GIS tools and experience.

If the consultant is a Joint Venture (JV), the Expression of Interest shall include:

- A copy of the JV Agreement entered into by all members. Alternatively, a letter of intent to execute a JV Agreement in the event of a successful proposal shall be signed by all members and submitted with the Expression of Interest, together with a copy of the proposed Agreement, indicating the leader and areas of expertise in the project.
- Justification of consortium or JV: complementary capacities and key technical fields of the consortium;
- For a JV, all the members of the consortium shall be jointly and severally liable; jointly and independently capable of executing the service

Among the submitted applications, LAMATA will shortlist a maximum of six (6) Applicants, to whom the Request for Proposals to carry out the Services shall be sent.

Statement of Integrity, Eligibility and Environmental and Social Responsibility

1. We recognise and accept that *Agence Française de Développement* ("**AFD**") only finances projects of the Contracting Authority subject to its own conditions which are set out in the Financing Agreement which benefits directly or indirectly to the Contracting Authority. As a matter of consequence, no legal relationship exists between AFD and our company, our joint venture or our suppliers, contractors, subcontractors, consultants or subconsultants. The Contracting Authority retains exclusive responsibility for the preparation and implementation of the procurement process and performance of the contract. The Contracting Authority means the Purchaser, the Employer, the Client, as the case may be, for the procurement of goods, works, plants, consulting services or non-consulting services.
2. We hereby certify that neither we nor any other member of our joint venture or any of our suppliers, contractors, subcontractors, consultants or subconsultants are in any of the following situations:
 - 2.1 Being bankrupt, wound up or ceasing our activities, having our activities administered by the courts, having entered into receivership, reorganisation or being in any analogous situation arising from any similar procedure;
 - 2.2 Having been:
 - a) convicted, within the past five years by a court decision, which has the force of *res judicata* in the country where the Contract is implemented, of fraud, corruption or of any other offense committed during a procurement process or performance of a contract (in the event of such conviction, you may attach to this Statement of Integrity supporting information showing that this conviction is not relevant in the context of this Contract);
 - b) subject to an administrative sanction within the past five years by the European Union or by the competent authorities of the country where we are constituted, for fraud, corruption or for any other offense committed during a procurement process or performance of a contract (in the event of such sanction, you may attach to this Statement of Integrity supporting information showing that this sanction is not relevant in the context of this Contract);

 - 2.3 Being listed for financial sanctions by the United Nations, the European Union and/or France for the purposes of fight-against-terrorist financing or threat to international peace and security;
 - 2.4 Having been subject within the past five years to a contract termination fully settled against us for significant or persistent failure to comply with our contractual obligations during contract performance, unless this termination was challenged and dispute resolution is still pending or has not confirmed a full settlement against us;
 - 2.5 Not having fulfilled our fiscal obligations regarding payments of taxes in accordance with the legal provisions of either the country where we are constituted or the Contracting Authority's country;
 - 2.6 Being subject to an exclusion decision of the World Bank and being listed on the website <http://www.worldbank.org/debarr> (in the event of such exclusion, you may attach to this Statement of Integrity supporting information showing that this exclusion is not relevant in the context of this Contract);

- 2.7 Having created false documents or committed misrepresentation in documentation requested by the Contracting Authority as part of the procurement process of this Contract.
3. We hereby certify that neither we, nor any of the members of our joint venture or any of our suppliers, contractors, subcontractors, consultants or subconsultants are in any of the following situations of conflict of interest:
 - 3.1 Being an affiliate controlled by the Contracting Authority or a shareholder controlling the Contracting Authority, unless the stemming conflict of interest has been brought to the attention of AFD and resolved to its satisfaction;
 - 3.2 Having a business or family relationship with a Contracting Authority's staff involved in the procurement process or the supervision of the resulting Contract, unless the stemming conflict of interest has been brought to the attention of AFD and resolved to its satisfaction;
 - 3.3 Being controlled by or controlling another bidder or consultant, or being under common control with another bidder or consultant, or receiving from or granting subsidies directly or indirectly to another bidder or consultant, having the same legal representative as another bidder or consultant, maintaining direct or indirect contacts with another bidder or consultant which allows us to have or give access to information contained in the respective applications, bids or proposals, influencing them or influencing decisions of the Contracting Authority;
 - 3.4 Being engaged in a consulting services activity, which, by its nature, may be in conflict with the assignments that we would carry out for the Contracting Authority;
 - 3.5 In the case of procurement of goods, works or plants:
 - a) Having prepared or having been associated with a consultant who prepared specifications, drawings, calculations and other documentation to be used in the procurement process of this Contract;
 - b) Having been recruited (or being proposed to be recruited) ourselves or any of our affiliates, to carry out works supervision or inspection for this Contract.
4. If we are a state-owned entity, and to compete in a procurement process, we certify that we have legal and financial autonomy and that we operate under commercial laws and regulations.
5. We undertake to bring to the attention of the Contracting Authority, which will inform AFD, any change in situation with regard to points 2 to 4 here above.
6. In the context of the procurement process and performance of the corresponding contract:
 - 6.1 We have not and we will not engage in any dishonest conduct (act or omission) deliberately intended to deceive others, to intentionally conceal items, to violate or vitiate someone's consent, to make them circumvent legal or regulatory requirements and/or to violate their internal rules in order to obtain illegitimate profit;
 - 6.2 We have not and we will not engage in any dishonest conduct (act or omission) contrary to our legal or regulatory obligations or our internal rules in order to obtain illegitimate profit;
 - 6.3 We have not promised, offered or given and we will not promise, offer or give, directly or indirectly to (i) any Person who holds a legislative, executive, administrative or judicial mandate within the State of the Contracting Authority regardless of whether that Person was nominated or elected, regardless of the permanent or temporary, paid or unpaid nature of the position and regardless of the hierarchical level the Person occupies, (ii) any other Person who performs a public function, including for a State institution or a State-owned company, or who provides a public service, or (iii) any other person defined as a Public Officer by the national laws of the Contracting Authority's country, an undue advantage of any kind, for himself or for another Person or entity, for such Public Officer to act or refrain from acting in his official capacity;
 - 6.4 We have not promised, offered or given and we will not promise, offer or give, directly or indirectly to any Person who occupies an executive position in a private sector entity or works for such an entity, regardless of the nature of his/her capacity, any undue advantage of any kind, for himself or another Person or entity for such Person to perform or refrain from performing any act in breach of its legal, contractual or professional obligations;
 - 6.5 We have not and we will not engage in any practice likely to influence the contract award process to the detriment of the Contracting Authority and, in particular, in any anti-competitive practice having for object or for effect to prevent, restrict or distort competition, namely by limiting access to the market or the free exercise of competition by other undertakings;

- 6.6 Neither we nor any of the members of our joint venture or any of our suppliers, contractors, subcontractors, consultants or subconsultants shall acquire or supply any equipment nor operate in any sectors under an embargo of the United Nations, the European Union or France;
- 6.7 We commit ourselves to comply with and ensure that all of our suppliers, contractors, subcontractors, consultants or subconsultants comply with international environmental and labour standards, consistent with laws and regulations applicable in the country of implementation of the Contract, including the fundamental conventions of the International Labour Organisation (ILO) and international environmental treaties. Moreover, we shall implement environmental and social risks mitigation measures when specified in the environmental and social commitment plan (ESCP) provided by the Contracting Authority.
7. We, as well as members of our joint venture and our suppliers, contractors, subcontractors, consultants or subconsultants authorise AFD to inspect accounts, records and other documents relating to the procurement process and performance of the contract and to have them audited by auditors appointed by AFD.
